

# Binding Agreement to Settle Case on Ujuz

- i. That the [Case Loser] will not appeal the case or the final award on the Ujuz website.
- iii. No Admission. This Agreement shall not be deemed to be an admission of any fact, allegation or statement made by either party.
- iv. Miscellaneous. This Agreement shall be binding upon the parties, their successors, assigns and personal representatives. Time is of the essence on all undertakings. This Agreement shall be enforced under the laws of the state of Colorado. This is the entire agreement between the parties and may not be modified or amended except by a written document signed by the party against whom enforcement is sought. This agreement may not be assigned or delegated by either party without the prior written consent of the other party.

This is the entire Agreement.
